OFFICERS REPORT:

PRESIDENT REPORT-Greg Delos Santos Jr.

- Update on Francisco attending the National Board of Directors Meeting, Notice had been sent out to members. January 17th to 21st. Reminded members to submit any concerns, comments, or suggestions that you wanted him to bring before the Board.
- GD-summarized efforts initiated at our last board meeting to revisit our current bylaws and organization chart.
- GD-noted that 2024/2025-chapter elections are coming up for vote.
 - Nominations will be held in our March General Meeting.
 - o Election of Officers will be held at our April General Meeting
 - CY raised the question of what officers are being voted on in consideration of our review of current By-Laws and Organization Chart.
 - SP outlined many of the redundant and obsolete positions contained in our current bylaws which haven't been revised since 1991.
 - SP noted we are in the process of whittling down and consolidating our organization to fit our current operations/requirements.
 - Discussion GD/CY concluding voting would be for current officers positions along with appointed state delegates, i.e. 7 positions. Future offices formed as part of the bylaw/organization chart review would be filled by special election (s).

VICE PRESIDENT REPORT-Steve Pennington

- SP-Provided update on obtaining your DD214, Ordering earned Metals. Use Std Form 180, copies available-contains instructions/addresses, takes about 6 weeks to process. Can also go online Google NVRC National Personnel Records Saint Louis. Be Patient
- SP-Briefed on lost records due to Fire in the NVRC Records Center-July 12th, 1973, 16-18 Mil Records were destroyed. Following records were affected:
 - Army Discharged between Nov 1st 1912 and Jan 1st 1960 (Dates encompasses Korean War Veterans)
 - Air Force Discharged between Sept 25th, 1947, and Jan 1st, 1964, and Last name after Harper James.

- SP-cited a story of a widow who was trying to reconcile stories she had been told and the official record which didn't agree. **The truth will be revealed**, don't let your family with the embarrassment of discovering the truth.
- Ron Foster-cited a story when he requested replacement ribbons and was also provided with ribbons that
 had been awarded that he had been eligible for but were not listed on his original DD214, i.e. Vietnam
 Gallantry Cross.
- SP-Summarized the Christmas Dinner provided to Sebastian House.
 - o 15 Meals were prepared and delivered. The members are VERY appreciative of the meals. This is a yearly event, and we are anticipating repeating this Service.
 - o Brief was provided of Sebastian house including requirements for getting accepted.
 - Jerry Matheson commented on his contact with Veterans at Salvation Army and what could they
 do to get acceptance into Sebastian House housing.
 - SP noted there is a two-step vetting process. Currently there are ~6 openings and could take around 4 weeks to complete the process. SP note he would provide Jerry Matheson with information/application and guidance on the process for acceptance.

SECRETARY REPORT-Jerry LaCombe

- JL notified December minutes had been issued, anyone not receiving needs to confirm having correct email address. Additional hard copies are available.
- Update on Action Item addressing Directors and Officers Insurance (D&O), previously confirmed that our
 national insurance did not cover local chapter for D&O. Only the National and State Officers and Directors
 are covered by our National Insurance Policy. Accordingly, I have applied with a local, Brown and Brown,
 Insurance broker to obtain a quote for D&O insurance. A guess of between \$700.00 and \$1000.00
 depended upon the organization.
 - Gave brief of what is covered by D&O insurance, i.e. protects officers and directors from having to put their personal assets on the line to defend a lawsuit. (ACTION ITEM-UPDATE)
- Update on Action Item addressing procedure covering Capital Improvement Projects (Vets with Hammers)
 - Draft Copy essentially complete, being held in abeyance pending resolution of new bylaws and organization chart. Additionally, Insurance coverage for capital projects is being investigated.
- Earl Shafer-questioned if our general liability policy covered construction projects. Confirmed it did not.
 - Terry Quick advised he was investigating and noted the following:
 - Our activities are like Habitat for Humanity, except smaller in scope.
 - We need to be listed with the State Labor and Industries and have a Bond in Place. If cited not having are paperwork/bond in place, we would be subject to a \$10,000.00 Fine.
 - Terry Quick provided a brief discussion he is having with Brown and Brown about what are the
 exclusions cited in our National General Liability policy. Discussion on activities we are involved
 in and what coverage is provided. Response from Brown and Brown pending (ACTION ITEMUPDATE).
 - O JL-Gave explanation of our insurance records-VVA 0423 has a copy of what is termed an ACCORD Short Form Declaration page. This is not the actual policy, analogy Car Insurance policy vs a card proving you have insurance that you carry in your glove box. Items on the short form that are noteworthy summarize what is not covered. Does not provide what are the deductibles' etc., need the actual policy.
 - GD-noted that all activities involving construction projects (Vets W/Hammers) are to be held in abeyance pending resolution of our Insurance and State requirements.
- Brian Seguin noted that in the December minutes the spelling of his last name was in error listed as Sequin.

- Provided update on Honor Flight noted that in December minutes, page 3, listed if your number is < 200 expect call in April, should read <50.
- JL noted that Bob Correll had advised, after December meeting reporting, that an action item about a \$289.00 web page invoice was not valid and could be closed.
- JL noted that Action item for Chris and Brian regarding American Legion Post 37 funding for Veteran Financial Assistance has been resolved.
- JL advised he had prepared a full yearly calendar of events and will be appending to the meeting minutes. Additionally, if any members want an event added to the calendar please advise. The calendar will be updated periodically.
- Special recognition was given from the floor praising the "End of Year Dinner" as the best.
- JL noted we had submitted an application/proclamation for VVA #423 to be listed as a "Purple Heart Entity" Questioned if receipt had been received by anyone-Response negative, can expect at any time.
 - A purple heart entity is given to an organization (entity) that recognizes (proclaims) the sacrifice that purple heart recipients have made for our country.
